VENDOR REQUIREMENTS

- 1) Food vendors must be self-contained and comply with all Orange County Health Department Code
- 2) All Food booths must have a valid OC Health Dept. Permit
- 3) All vendors must comply with the San Clemente City Resolution #04-27 which prohibits the use of any styro-foam
- 4) Trash, food debris, food residue, and other waste must be removed at the conclusion of the event
- 5) At no time shall waste or wastewater be allowed to enter the city's storm drain system. (Includes gutters)
- 6) Mandatory that all booths be decorated for Christmas**
- 7) LED LIGHTS ONLY, we will remove you from the event if you do not have LED lights.**
- 8) No outdoor cooking allowed
- 9) Refunds will only be given if RAIN and the event is cancelled
- 10) Vendors must supply their own easy up.
- 11) Electrical will only be available for the use of LED lighting inside your booth.
- 12) We are not responsible to power any of the following items: Coffee Makers, Hot Chocolate Warmers, Popcorn Machines, and Hot Plates
- 13) All Non-Retail Booths are required to have a children's interactive activity.

WAIVER: I hereby give the San Clemente Downtown Business Association the right to use photographs taken of me or my activity, for reproduction in any medium for purpose of trade, advertising, display, exhibition or editorial use.
